

Description

Faraday House is a detached headquarters warehouse/office building constructed in 1988. The property is of steel frame construction with an office area occupying the front section of the building, separated from the warehouse/production area by a service corridor, with large toilet and shower facilities at each end.

There is an extremely good level of natural daylight throughout the property provided by the fully glazed front elevation, the windows to the side elevations and the rooflights spanning the full width of the property.

Location

The building occupies a prominent and elevated corner plot at the junction of Davy Avenue and Roebuck Way, two of the main roads through the Knowlhill employment area of Milton Keynes.

Knowlhill has excellent road links to the rest of MK via the major urban "grid roads" H6 Childs Way, H7 Chaffron Way and V4 Watling Street. The property is 1.5 miles from Milton Keynes Central railway station and 4.0 miles from J14 of the M1 motorway.
